Kalra Named Chair of Aging Long Term Care Committee

After being sworn into office on December 5, 2016, the first month in State Assembly was definitely an exciting one for Assemblymember Ash Kalra. Kalra was named Chair of the Assembly Committee on Aging & Long-Term Care by Assembly Speaker Anthony Rendon. He could not be more honored to be serving in this role.



The Committee's primary focus includes: California Department of Aging, long-term supports and services, Older Americans Act, Older Californians Act, senior citizen advo-

cacy activities, the California Senior Legislature, services for seniors in residential and day settings, and the California Commission on Aging.

"I am truly grateful to the Speaker for naming me Chair of the Committee on Aging and Long-Term Care," stated Kalra. "Now, it is more important than ever for those of us in leadership in California to protect our seniors and ensure they continue to have ever-increasing access to quality healthcare and long-term care by protecting Social Security and Medicare, while expanding additional programs for continuing care. I look forward to being a strong advocate for the aging and ensure our Committee is effectively positioned to protect the interests of California seniors."

Community Members Recognized at African American History Month Celebration

On Thursday, February 23rd, in honor of Black History Month, Assemblymember Ash Kalra and African American Community Service Agency (AACSA) collaborated to host the first-ever Black History Month Recognition Celebration Event. The AACSA has been the home of San José's African American leaders since 1978, and an agency Kalra has long supported throughout his years of service, which made the collaboration even more perfect.

It was a very exciting evening, with around fifty people in attendance to honor the many wonderful leaders in the African American community. The event began with a message from AACSA Executive Di-

rector Milan Balinton, followed by Angela Tirado who sang the the Negro National Anthem. Assemblymember Kalra then presented State Resolutions for five categories to five amazing

It was a successful first Open House on March 16th for Assemblymember Kalra, who welcomed over a hundred community members and constituents to his new District Office located off Paseo de San Antonio in downtown San José, a few blocks away from his old office at San José City Hall. It was a wonderful opportunity for residents to learn more about their new State Assembly representative, what services are offered, and it was also a great chance for constituents to meet the staff that are at their service here in the District Office.

The community event included food from amazing downtown businesses, including Pizza My Heart, Tandoori Grill, and Academic Coffee. There

were also informational resources, such as books on the California Legislature and the California Constitution, tax information booklets, constituent brochures on State services, and more. The Open House also welcomed many elected officials and leaders, including Vice Mayor Magdalena Carrasco, Councilmember Raul Peralez, and San José Fire Department Chief Curtis Jacobson.

Assemblymember Kalra spent the Open House meeting his constituents and learning about their concerns. He also talked about the multitude of bills he introduced, including AB 21, aimed at protecting undocumented students at all of California's colleges and universities, and AB 20, which asks to di-

vest State pension funds from the Dakota Access Pipeline.

We are so grateful for all who joined us at our first Open House, and hope that we will be able to serve all our constituents to the best of our ability in our new role in State Assembly.



REMEMBER, YOU HAVE RIGHTS UNDER THE CONSTITUTION, REGARDLESS OF YOUR IMMIGRATION STATUS.



1. You have the right to remain silent.
2. You have the right to speak with a lawyer.
3. If law enforcement shows up at your house,
DO NOT OPEN THE DOOR.
Ask them to slide the warrant under the door.
It has to be signed by a judge, and have your name.
4. Never carry false documentation with you (it's a crime).
5. If detained, only say your name and DOB.

The Chavez Family Vision hosted their Annual Breakfast and Scholarship Presentation on Friday morning to recognize various local leaders that have given back to the community, as Cesar once did. Assemblymember Kalra had the honor of attending the breakfast, and presenting a State Resolution to the keynote speaker, Dr. Francisco Jimenez. In addition, the Chavez Family awarded young leaders with scholarship funds they raised to help their way through college. Three young women were awarded the Cesar E. Chavez Family Vision Scholarship award, and all showed gratitude towards receiving this scholarship. In addition, the Chavez Family

recognized a leader who has lived the life as Cesar Chavez would by awarding Mickie Luna the Si Se Puede Award. Following these awards, I had the honor of presenting the scholarship recipients and Mickie Luna with Certificates of Recognition for their hard work and dedication and recognizing the Chavez Family with for their contributions to inspiring the generations ahead of them. I was honored to present a Resolution on behalf of the State of California to Dr. Francisco Jimenez, who has gone through migrant challenges and surpassed all the obstacles and achieving his goals. Spreading the Word about California's Paid Family Leave Program

California was the first state in the nation to offer Paid Family Leave (PFL) in 2004, but there are still many people who don't know about the program even though they contribute to it through their State Disability Insurance payroll deductions. Beginning this month, you'll learn more about PFL as the California Employment Development Department launches "Moments Matter," a statewide public education campaign designed to spread the word about this beneficial program.

"Moments Matter" is an appropriate name for this campaign since PFL helps Californians make the most of the important moments in life. California's Paid Family Leave (PFL) is a state-administered program that can provide some needed financial support to help employees take time away from work during important moments in their lives. This family-friendly program is available when you need the time to bond with a new child or to care for an ill family member. Eligible workers can receive up to 55% of their normal weekly pay – from \$50 up to \$1,173 in weekly benefits – for up to six weeks within any 12-month period.

Hundreds of thousands of Californians have benefited from Paid Family Leave over the last 12 years. That's a good start. The "Moments Matter" public education campaign will help spread the message to an audience of millions, reaching out to those who would benefit from precious time with family members.
