AD 25 Commemorates 48th Black April

April 30th marked the 48th Black April, or Tháng Tư Đen, in the County of Santa Clara, which is home to the second-largest Vietnamese overseas community in the United States. Across the 25th Assembly District, members of the Vietnamese community and their allies solemnly gathered to observe the raising ceremony of the yellow-and-red-striped flag of the Republic of Vietnam, paying tribute to the lives lost during the Fall of Saigon in 1975. At that time, hundreds of thousands of Vietnamese refugees fled their homeland on small boats in search of freedom in unfamiliar lands, knowing that their rights would suffer under the new communist regime.

The Assemblymember began his day by attending the annual Black April Commemoration at the Viet Museum in History Park, where he honored the heroic service members who fought for democracy and human rights in Vietnam. Subsequently, he participated in the commemoration event hosted by the Vietnamese American Roundtable. Assemblymember Kalra's office presented a certificate of recognition to the County's Vietnamese American Service Center in acknowledgment of the Center's Black April Commemoration.



Kalra expressed his gratitude, saying, "I would like to extend my thanks to our community leaders and human rights activists for their ongoing commitment to commemorating Black April. It is crucial that younger generations are educated about the resilience of Vietnamese refugee communities and stand in solidarity, on the right side of history."

The following month, Kalra displayed his commitment to advocating for freedom and human rights for the oppressed people of Vietnam on the floor of the Assembly. He played a crucial role as a principal co-author of ACR 45, introduced by Assemblymember Tri Ta. This resolution, adopted by the California Legislature, establishes May 11th as Vietnam Human Rights Day in California.

Silicon Valley Dental Clinic: Honoring Community with Care

On May 20th, Asm. Kalra was honored to tour the Silicon Valley Healthy Smiles (SVHS) Free Dental Clinic. The clinic took place at the San José Convention Center's South Hall and showcased a significant initiative organized by the Santa Clara County Dental Foundation (SCCDF) and SVHS Committee Chair, Dr. Ken Wallis, providing dental care to over 1,500 underserved members of the Silicon Valley Community.

Asm. Kalra observed the impressive scale of the 100-chair operation, capable of accommodating numerous patients simultaneously. The clinic offered a wide range of dental services, including cleanings, fillings, extractions, dentures, and assistance in finding long-term dental care. The collaboration between dental professionals and local community members who generously donated their time and assistance to support this noble cause was truly remarkable.

The SCCDF aims to establish the clinic as an annual or semi-annual event, having successfully raised approximately \$400,000 this year. However, the foundation is actively seeking additional donors to ensure the continuity of such clinics in the future. In addition to the dental clinic, the SCCDF provides various other services, including dental student scholarships and dental care. Moreover, the foundation partners with community leaders and service organizations to offer access to restorative dental care and oral health services to hundreds of deserving individuals.



Kalra commented, "I am genuinely excited to continue supporting the SCCDF in their valuable mission of bringing healthier and happier smiles to San José and the greater South Bay region. During our tour, I couldn't help but feel grateful for the opportunity to represent such an engaged and cooperative community, dedicated to each other's well-being. This celebration is a recurring part of the Assemblymember's annual in-district events.

While honoring the remarkable advocates and leaders within the AAPI community in AD 25, Asm. Kalra emphasized the ongoing struggle for civil rights endured by the AAPI community throughout history. He expressed, "As a proud member of the AAPI community, I recognize the immense effort required to gain visibility and acknowledgment, despite the challenges posed by the prevailing system in this country, which often hinders our community's progress. From 1972 to 2012, she worked at the Santa Clara County Social Services Agency, where she advocated tirelessly for children and families until her retirement.

Leadership in Community Empowerment: Jonathan Cam Leaupepetele has been involved in community work for over 10+ years with his nonprofit organization, CamCamp, which is a free workout, mentorship, & counseling service for the youth in San José. Since 2012, this program has served as an outlet for troubled youth in need of guidance and advice.

Leadership in Business – Japantown Business Association is a non-profit organization dedicated to promoting San José's Japantown as a unique ethnic neighborhood. With over 150 members comprised of local businesses, associations, and community organizations, JBA has played an important role in Japantown's continuing vitality for 30 years.



Leader in the Arts – Hang Huynh is a contemporary artist who is interested in sculpture, photography, and oil painting. As a teaching artist and class coordinator for Chopsticks Alley Art, Hang advocated through her art for the depiction of the beauty of Southeast Asian cultures.

Santa Clara Valley Open Space Authority Celebrates 30th Anniversary



Despite a light rain, environmental advocates and organizations gathered to celebrate the 30th anniversary of the Santa Clara Valley Open Space Authority with undiminished joy. "By directing all state agencies to coordinate their departments and programs, California can ensure that its efforts in achieving the 30x30 goals are harmonized. This coordinated approach will enhance transparency and accountability in implementing the necessary measures to conserve our lands and waters," Kalra shared.

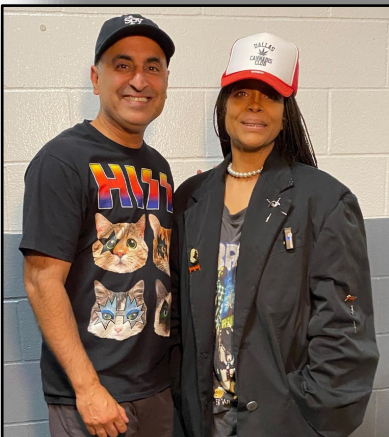
The event was not just about speeches and serious discussions, however. There was a real sense of community intensified by the mouth-watering Filipino food by the members of PAWIS South Bay.
